Sealed bids for the construction of the Project will be received at the Administration Building of the Fox Metro Water Reclamation District located at 682 State Route 31, Oswego, Illinois 60543, until March 18, 2026 at 10:00 AM local time. At that time the Bids received will be publicly opened and read.

The Project includes the following Work:

Installation of approximately 1,058 feet of 69/72-inch diameter cured-in-place pipe (CIPP), one new manhole, replacement of a concrete flat top structure, by-pass pumping, heavy cleaning, manhole chimney lining and other miscellaneous items of work.
