ORDINANCE NO. 953

“AN ORDINANCE OF THE BOARD OF TRUSTEES OF FOX METRO WATER RECLAMATION DISTRICT, KANE, KENDALL, DUPAGE AND WILL COUNTIES, AMENDING THE FOX METRO WATER RECLAMATION DISTRICT CODE OF ORDINANCES WITH RESPECT TO USER RATES”

WHEREAS, the Fox Metro Water Reclamation District (the “District”) has previously established user rates; and

WHEREAS, the user rates adopted call for an increase of the user rates on May 1, 2026; and

WHEREAS, the District’s Board of Trustees has determined that it is not necessary to increase the user rates on May 1, 2026.

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of Fox Metro Water Reclamation District, as follows:

Section One: Code Amendment. That Section 10.38 of the District’s Code of Ordinances be and the same is hereby deleted and the following inserted in its place:

Sec. 10.38. User rate established.

(a) There shall be and there is hereby established and imposed upon all users of the District’s wastewater facilities and sewerage system a User Charge of **\$8.26** per 1,000 gallons of water consumption to be computed as set forth herein and in other applicable District Ordinances. Rates shall be reviewed biannually in the rate study.

Section Two: Severability. In the event that any word, phrase, clause, sentence, paragraph, provision or section of this Ordinance, or any part thereof, shall be held to be unconstitutional, unenforceable or void, the same shall not affect the validity or enforceability or any remaining words, phrases, clauses, sentences, paragraphs, provisions or sections of this Ordinance, in addition to, but not in lieu of any other civil remedies which may be available to the Village of Channahon.

Section Three: Repealer. All Ordinances or parts thereof which conflict with any term, condition, provision or section of this Ordinance be and the same are hereby repealed.

Section Four: Effective Date. This Ordinance shall be in full force and effect from and after its passage, approval by the President, its attestation by the Clerk of the Board of Trustees of Fox Metro Water Reclamation District.
